

Terms and conditions for the 'oldest working Foster Refrigerator product in the UK' competition 2018

1. General:

1. Oldest Foster Refrigerator product in use competition ("Competition") organised by Foster Refrigerator, a division of ITW registered in England and Wales No. 00559693, established and having offices at Oldmedow Road, King's Lynn, Norfolk, PE30 4JU
2. From 6 July to 1 October 2018, commercial kitchens can take part in the Foster competition ("Promotional Period").

Foster Refrigerator reserves the right at all times to terminate, pause or modify the promotion, unilaterally and without prior notice and/or to change the terms and conditions and/or the promotional products/prices if circumstances so require, without in any way to be liable to pay compensation to the participants.

2. Participants:

1. Participation in the Competition is open to all commercial caterers and dealers, with the exception of Foster Refrigerator employees and their family members and/or its affiliates.
2. Participation in the Competition is only for persons with a permanent place of residence and stay in the UK.
3. Participation in the Competition implies acceptance of the competition terms and conditions. No disputes about these terms and conditions will be considered.
4. Participants must cooperate with any reasonable requests from Foster Refrigerator to participate in promotional activities related to the Competition.
5. Foster has the right to exclude a participant if it appears that the participant has provided inaccurate, incomplete or misleading information, or otherwise commits fraud or attempts to commit fraud.

2. The Foster Refrigerator product submitted to the Competition must still to be in operation on a UK commercial kitchen every day.
3. The submitted Foster Refrigerator product information to the Competition is assessed on the basis of the serial number on the refrigeration product to determine the demonstrable age.
4. The Foster Refrigerator product submitted to the Competition must be owned by the participant. A dealer cannot enter on behalf of the owner without the owner's written consent.
5. If the owner of the product is referred by a dealer, the owner must state the dealer at the point of entering. If the owner purchased the product directly from Foster Refrigerator, no dealer will receive the discount.
6. Foster Refrigerator may request an inspection of the entry on site for verification of the submission to the Competition.

4. Prizes:

 - a. Oldest refrigerator prize: Foster Refrigerator EcoPro G2 EP700H valued at £2500 (list price)- including installation OR an alternative Foster Refrigerator product of comparable value.
